## Wintawari Guruma Enterprises P/L

In May 2014, Wintawari Guruma Enterprises Pty Ltd (WGEPL) was established to take advantage of the commercial opportunities on country for the benefit of the EG people. The shares in this company are wholly owned by the Corporation.

WGEPL is the only Eastern Guruma business that has been established to represent the interest of the community.

To enhance our skills and boost our growing capability, the Board has appointed Tony Bevan as Chief Executive Officer of WGEPL and Phil Paul as Business Development Manager.

Reporting to the Board, both Tony and Phil have strong backgrounds in their respective fields and have achieved positive results for the business. All profits generated by WGEPL will be returned to the Corporation, for the benefit of the community.

**WGEPL has been awarded its first direct contract - to provide five items of equipment plant on long term hire to Indigenous Construction Resource Group (ICRG) to be used on the maintenance of the Nunutarra Road for FMG. The equipment was purchased for around \$1.5m and will be fully paid off in three years. The equipment comprises:**

- Cat 140M grader
- 30,000L prime mover & water tanker
- Cat 966H Loader
- Service & Maintenance truck

**WGEPL has also entered into a four year plant hire agreement with Brierty Limited, resulted in WGEPL purchasing a Komatsu Multi-Tyred Dozer for use on the RTIO Western Turner Syncline Project.**

WGEPL has also been developing a relationship with Downer Mining, looking at sub-contracting opportunities for the now deferred Silvergrass Mining tender. This relationship will also provide other Eastern Guruma business's the opportunity to participate with WGEPL on a large mining project.

### **Muntulgura Guruma Pty Ltd (MG)**



In May 2014, Indigenous Construction Resource Group (ICRG) and WGAC agreed to establish a civil construction business, to undertake civil projects on Eastern Guruma country. This business is a 50:50 incorporated entity, with equal ownership and control.

MG has been awarded its first contract at Solomon providing a 24/7 train loading operations over 2 years with a value of around \$8million a year.

MG has also been nominated by FMG to participate in undertaking various de-watering projects across the various FMG Mine sites.

In recent weeks MG and Brierty Limited have agreed to enter into a joint venture arrangement to undertake larger civil projects on country. The JV provides additional capability to MG and ensures that Eastern Guruma participation on projects remains relevant.
